Rules for the Award of GOLD MEDAL approved as Syndicate Resolution No. 11 & 15 both dated 29/11/2013 respectively.

- 1. The minimum donation for the Institution of Gold Medal is Rs. **2,00,000.00** (Rupees Two Lakhs only).
- 2. The donation amount will be invested and the interest earned will be used for preparation of the Gold Medals.
- 3. This donation towards the Gold Medal, which is accepted by the University, shall be subject to all prevalent general terms and conditions for the award/continuation of the gold medal as approved and revised from time to time by the Syndicate/Senate/other authorities of the M.S University of Baroda.
- 4. The Gold Medal which is accepted by the University is for 25 years from the date of acceptance of the request of the Donor by the University Authority.
- 5. The Gold Medal shall be named as

- 9. The Vice-Chancellor of the M. S. University of Baroda shall be the Final Authority in deciding all the points of disputes / issues, which may arise in awarding the Gold Medal.
