ABOUT THE FACULTY

The Former Baroda State Government created on the 17th December 1948 a Women's Education Trust Fund to establish a Home Science College in Baroda. The Trustees handed over this Educational Fund to the newly established The Maharaja Sayajirao University of Baroda for constructing a building for the Faculty of Home Science.

The University started a Nursery School Chetan Balwadi in June 1949 and on 3rd July, 1950 established the Faculty of Home Science. Evolving from its humble beginnings, the faculty has made conscious efforts towards redefining and broadening its view in response to the rapidly changing national and global scenario. There has been introduction of several new courses, modification of the syllabus and curriculum as per the changing demands of the society and industry.

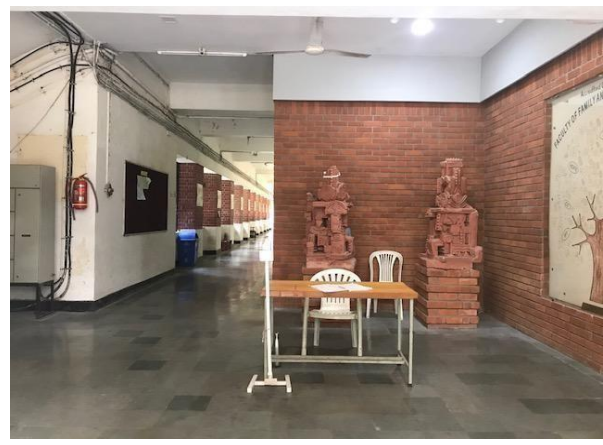

- To impart professional training to students and broaden their horizons by exposure to micro and macro level issues in the rapidly changing social and technical environments.

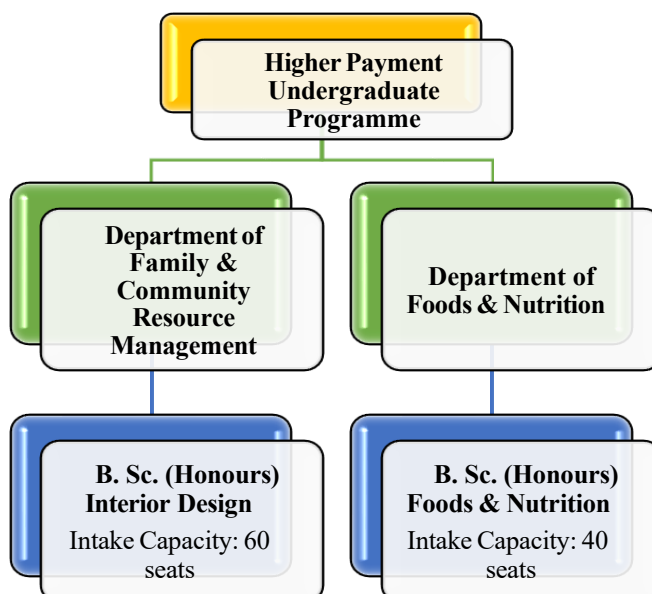

HIGHER PAYMENT UNDERGRADUATE PROGRAMMES OFFERED BY DEPARTMENTS

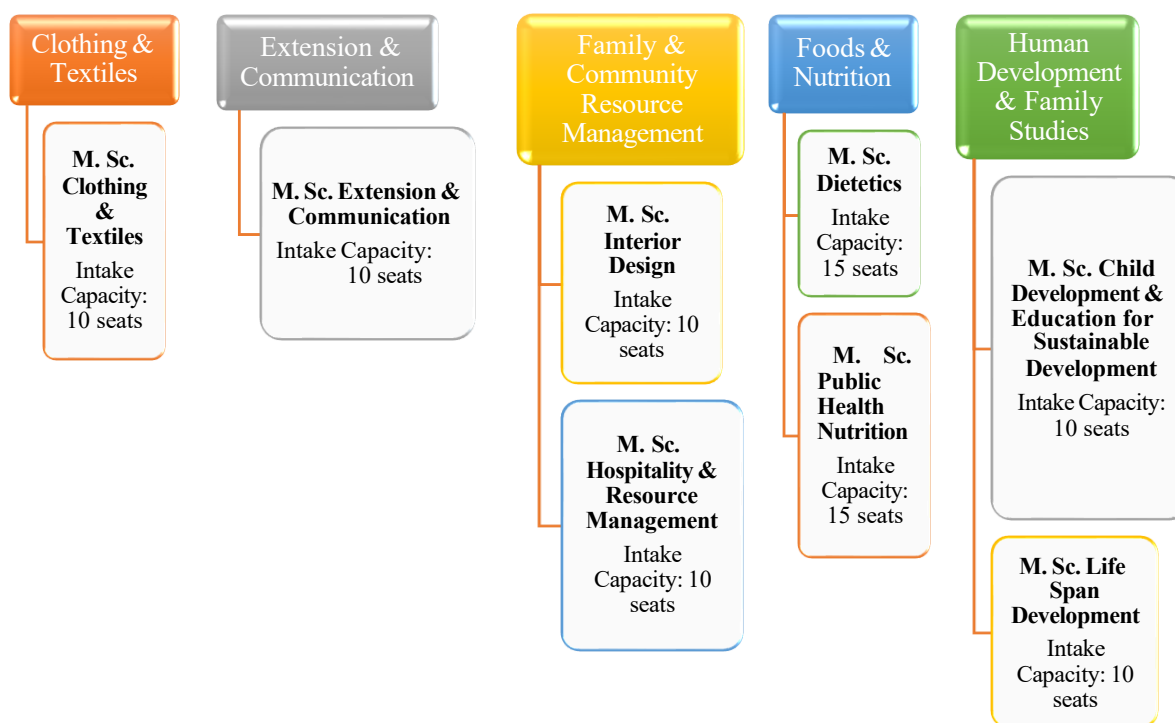


GRANT-IN-AID POSTGRADUATE PROGRAMMES OFFERED BY THE DEPARTMENTS

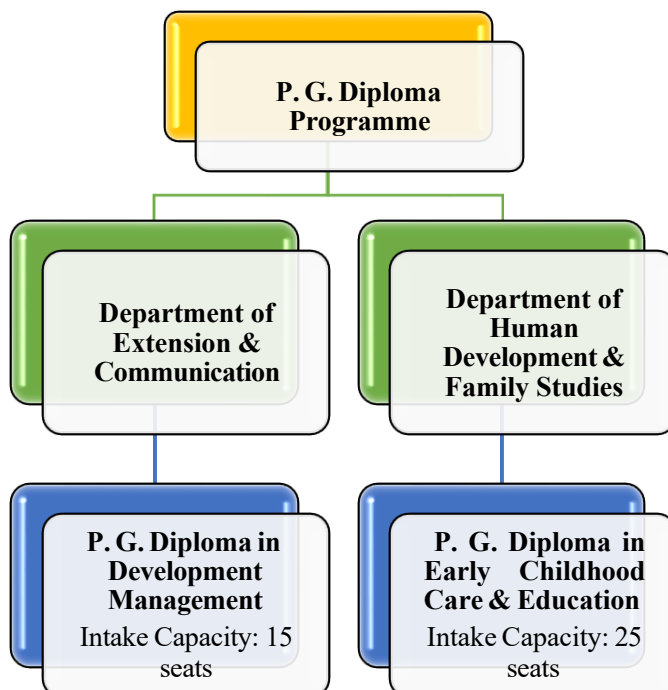

CREDIT DISTRIBUTION FOR POSTGRADUATE PROGRAMME

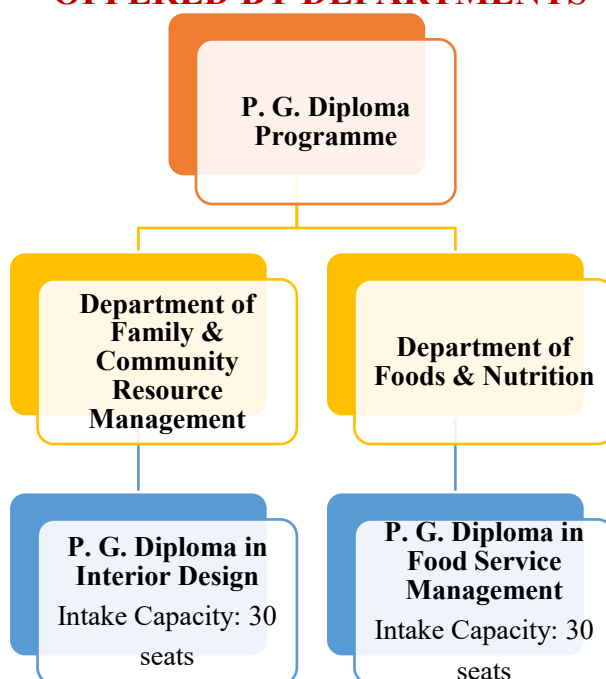

Ph. D. programme is offered by all the five departments of Family and Community Sciences namely,

- Clothing and Textiles
- Extension and Communication
- Family and Community Resource Management
- Foods and Nutrition
- Human Development and Family Studies

ELIGIBILITY CRITERIA

a. Undergraduate (Honours) Programmes

The applicant should have passed Std. 12th (H.S.C.) - Science/ General Stream or equivalent Examination from a recognized board with ENGLISH as one of the subjects. If the applicant has passed XII Examination without English as a subject but through English as a medium of instruction in school, a certificate from the school needs to be attached stating particulars about medium of instruction.

b. Postgraduate Programmes and P. G. Diploma Programmes

c. Ph.D. Programmes

1. Candidates for admission to the Ph.D. Programme shall have a Master's degree or a professional degree declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate without including the grace mark procedures or its equivalent grade in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) or an equivalent degree from a foreign educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions.
2. A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/SEBC (Non-creamy layer)/Differently-abled and other categories of candidates as per the decision of the Government of Gujarat and other Statutory bodies, as applicable, from time- to-time, or for those who had obtained their

Master's degree prior to 19th September, 1991. The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible based only on the qualifying marks without including the grace mark procedures.

3. Provided further that, if in spite of the above relaxation, the seats allotted for SC/ST/SEBC (Non-Creamy layer)/Differently-abled categories remain unfilled, a Special Admission Drive shall have to be launched, for that particular category within one month from the date of closure of admissions of General Category. It shall have to be ensured that most of the seats under these categories are filled.

4. The course-work shall be treated as a prerequisite for the award of Ph.D. degree. All research scholars admitted to the Ph.D. Programme shall be required to complete the course-work prescribed by the University/Faculty/Department during the initial one or two semesters.
5. A research scholar having completed the Pre-Ph.D. course-work from another university and moving to The Maharaja Sayajirao University of Baroda, shall be exempted from the coursework. The credits so obtained shall be treated at par with the credits of this University.
6. The Ph.D. scholar has to obtain a minimum of 55% of marks in the prescribed Grade Point Scale (or an equivalent grade/CGPA in a point scale wherever grading system is followed) and Structure of the University in the course-work in order to become eligible to continue in the respective Programme and submit the dissertation/thesis, as the case may be.
7. For Ph. D. admission, students who qualify for fellowship/scholarship in UGC-NET/UGC-CSIR NET/GATE/CEED and similar National level tests and/or students through MSU PET are eligible for interview.
8. For Ph.D. admission, interviews will be conducted for eligible students by the Departmental Admission Committee (DAC).
9. A Physical/Virtual interview shall be organized by the DAC. The candidates must discuss the concept of their research proposal in a presentation before DAC.

IMPORTANT NOTE

Personal Aadhaar card number, Email-ID and Mobile number are must for registering the application for Admission in any of the programmes of The Maharaja Sayajirao University of Baroda. The applicant is supposed to be present in person at the Faculty of Family and Community Sciences as per the admission schedule with the print out of the online registration form, relevant documents in original, one set of its self-attested photocopies and two passport size photographs for Admissions. Thalassemia screening programme is compulsory for each admitted student of The Maharaja Sayajirao University of Baroda. The Thalassemia screening programme may be done at the University Health Centre or University Pavilion at a discounted fees of rupees 150/- per student towards the cost of sample testing by “Red Cross Society”, India. Students must produce a Thalassemia screening certificate for obtaining the final eligibility.

KEY CONCEPTS (TAKEN FROM GR No: KCG/admin/2023-24/0607/kh.1.)

- A. **Assessment** is the process of determining that the learner has achieved the outcomes of the module. No credit can be earned by the learner unless programs is assessed for the achievement of outcome of a program.
- B. **Assessment Band** NCrF level be equated with the assessment mandatory stage of academic, vocational or experiential learning which must be cleared by the learner. Clubbing of levels (If any between two mandatory stage) has been referred as Assessment band.
- C. **A Credit** is a unit by which the coursework is measured. It determines the number of hours of instruction required per week over the duration of a semester (Minimum 15 weeks).
 - 1 Credit of Classroom theory = 15 hours of engagement in a semester
 - 1 Credit of Practical/Internship/workshop-based activity/theory under ODL = 30 hours of engagement in a semester

- 1 Credit of Field Visit/Industry visit/Assignments - 40-45 hours of engagement in a semester
 - Research Project/Dissertation: Entire Eighth Semester
- D. **A Credit Scheme** is a formal mechanism for awarding credits in respect of learning achievements.
- E. **Credit Accumulation:** The credit would be given for every kind of learning which are of each qualification and these credits can be accumulated in Academic Bank of Credits (ABC).
- F. **Credit Storage:** ABC shall enable an individual to digitally keep record of all the learning acquired and accumulated in terms of credits points throughout life in a common account irrespective of types of learning i.e., academic, vocational or experiential.
- G. **Credit Transfer** is a process by which credits are recognized by the concerned awarding body and mutual acceptance of credits between two entities.
- H. **Credit Level** defined on the basis of the cumulative number of years of learning with assessment.
- I. **Choice Based Credit System (CBCS)** provides an opportunity for the students to choose courses from the prescribed courses basket comparing Major/Core, Minor/Elective of Skills Based (Vocational) courses.
- J. **Credit Framework** means the framework, built to measure units of education, skills, and learning credits for a student to achieve the competency for performing a job role successfully or efficiently.
- K. **Entry Eligibility:** The acquired and accumulated credits points by the learner needed for moving to a particular level after undergoing academic, vocational or experiential learning. These credits points must have been accumulated from the lower adjacent assessment band.
- The accumulated credits are with respect to each assessment band.
 - Academic equivalence possible only within the same assessment band
- L. **Learner/Student** refers to an individual undergoing general or vocational education, whether in a formal or informal setting.
- M. **Learning Hours:** Total outcome-based learning hours for credits shall include:
- Classroom Teaching / Tutorials / Group Discussions / Video / Presentation / Online Teaching, etc.
 - Lab work/Practical/Projects/Assignments

- Sports/Games/Physical Activities/Yoga
- Social/Community work (Including NCC/NSS participation)
- Internship/Apprenticeship/On the Job Training (OIT), experiential learning (field visit, industry visit) etc.

N. **Level of Courses:** UG courses shall be coded based on the learning outcomes, level of difficulties and academic rigors. The Coding structure may be 0 - 99 (Pre-requisite level), 100 - 199 (Foundation or Introductory level), 200 - 299 (Intermediate level), 300 - 399 (Higher level) and 400 - 499 (Advanced level), 500-599 (First year course for two years master's degree Programme), 600 - 699 (Second year course for two years master's degree Programme), 700 - 799 & above (Courses of Doctoral students).

O. **Learning Outcomes** represent what a learner knows, understands and is able to do on a completion of a learning process. It would be expressed in terms of knowledge, skills and competence.

P. **Level of Learning** is one of the dimensions evaluated in the process of determining credit rating of learning achievement.

Q. **A National Credit System** is a framework with a set of specification that is used by all institution and awarding bodies.

R. **Notional Learning Hours** for one year of education/training across higher and vocational education have been agreed to be 1200 hrs for the purpose of assignments to award 40 credits subject to assessments.

S. **Skills** means the ability to apply knowledge and use know-how to complete task and solve problems.

T. **Sector** means a grouping of professional activities on the basis of their main economic function, product, service and technology.

DISTRIBUTION OF CREDIT AND SELECTION OF COURSES ACROSS FOUR YEARS DEGREE PROGRAMMES

Major Discipline

Major discipline is the main focus (core) dominant subject, and the degree will be awarded in that discipline. Major selection will be done in the 1st semester as per the guidelines given for major selection of the Faculty of Family and Community Sciences. A student pursuing four- year undergraduate programme in a specific discipline (Core course) shall be awarded appropriate Honours degree with Major in a Discipline on completion of VIII Semester, if

he/she secures in that Discipline at least 50% of the total credits i.e., at least 88 credits in that Discipline out of the total of 176 credits. S/he shall study 22 core courses and 8 minor courses in eight semesters to get Honours degree with or without research.

Minor Discipline

Minor discipline is the broader understanding course beyond the major discipline course. It helps students to gain broader knowledge in addition to relevant major disciplines. A student may be awarded Minor in a discipline, on completion of VIII Semester, if he/she earns minimum 24 credits from six minor courses of that discipline. For example, if a student pursuing B.Sc (Honours) in Public Health Nutrition chooses six Minor courses of Extension and Communication and writes dissertation, he/she shall be awarded on successful completion of VIII Semester, Major in Public Health Nutrition and Minor in Extension Communication.

- Minor subjects maybe from same or different disciplines as per the choice of the students.
- The credit of minor subjects shall be minimum 24 credits for 3 years bachelor's degree and minimum 32 credits for 4 years bachelor's degree programme.

Ability Enhancement course (AEC), Skill Enhancement Course (SEC), Value-Added Course (VAC) and Multidisciplinary Course (MDC)

These courses shall be a pool of courses offered by the faculty in odd and even semesters.

Interdisciplinary / Multidisciplinary Course (MDC) / Allied Courses

This is constituent discipline of the major courses and it helps learners to acquire core competence in relevant or any other independent courses of their choices. This course maybe major specific or other discipline specific. Learner shall have option to choose the course from the available pool of courses. MDC are courses which will provide multidisciplinary or interdisciplinary education to students.

Ability Enhancement course (AEC)

AEC courses offered to students to achieve competency in a Modern Indian Language and English Language focused on language and communication skills. It may be a major specific course.

Skill Enhancement Course (SEC)

SEC courses are aimed at imparting practical skills, embedded internship, hands-on training,

soft skills, life skills, such approved online courses etc to enhance employability of students. This may also include courses as per the need of new evolving technology.

Value-Added Course (VAC)

VAC courses are aimed at enabling students to acquire and demonstrate knowledge and understanding of contemporary India with its historical perspective. VAC courses are value-based courses which are meant to inculcate ethics, culture, environment, constitutional values, soft skills, sports education and such similar values to students which will help in all round development of students.

Summer Internship/ Field Projects/ Apprenticeship / Community Engagement and Service corresponding to Major Subject, Co-Curricular Courses and Research Project

- The Universities compulsory offer Internship/ Apprenticeship to the students corresponding to Major specific NSQF defined course in summer vacation, which will be mandatory to exit in first and second year of the three/four years degree programmes.
- Field projects/Community Engagement and services, corresponding to Major subject to be offered in first and second year, which shall fulfil the job opportunities in many fields with their knowledge and skills. Each University/Educational Institute shall coordinate/make MoU with various recognized training centers.

Research Project/Dissertation:

- It will be offered to students who have minimum aggregate of 75% of marks in first six semester and wish to take research at undergraduate level. Students can choose a research stream in fourth year.
- The research project / dissertation will be in major discipline with minimum 12 credits.
- The student securing the required number of credits at the end of four years along with minimum 12 credits of research/ dissertation will be awarded with a degree of Honours with Research.

OBJECTIVES OF NATIONAL EDUCATION POLICY 2020

- To promote holistic development of every student in both academic and non-academic areas with a shift in focus from the teacher-centric to student-centric education.
- To provide flexibility to slow learners and advanced learner students so that they can choose to learn at their own pace and choice.
- To provide multidisciplinary and developmental education in the broader domain of family and community sciences.

- To promote creativity and critical thinking and to encourage in problem solving activities.
- To Integrate Indian Knowledge systems, Ethics and Development Goals into the curriculum.
- To promote communication skills in learning and teaching.
- To impart life skills education to the learners.
- To promote need based research culture for outstanding education and development.
- To provide flexibility for students to study at different times and at different institutions to complete one course (ease mobility of students). Credits earned at one institution can be transferred to another institution.

STRUCTURE OF UGCF 2023

The UGCF is a structure for four-year undergraduate programmes in different disciplines with multiple exit options. The details of the structure are provided below in Table -1 for Grant in Aid programme and HPP programme.

Note:

1. A student has to secure a minimum of 50% credits from the major discipline for the 3Y/4Y UG degree to be awarded a single major.
2. Internship in 6th Semester shall be in major specific courses and credit allotted for internship would be compulsorily counted under Major course.
3. 4 Year Undergraduate Honours students not undertaking research will do 3 courses for 12 credits in lieu of the Research Project/Dissertation.
4. The research project/dissertation will be in a major discipline with 12 credits.
5. Honours students not undergoing research, will do OJT in 7th and 8th semester in lieu of a research project, which will be awarded Honours degree to the students.
6. Basic Research methodology shall be offered as one of the courses in semester V/VI & Advanced Research Methodology in semester VII.
7. Students studying courses offered by any discipline other than his/her core discipline/Major will be treated as Minor for that student.
8. The student can Minor in another discipline (YYYY) if the student fulfils 6 papers (YYYY) of minor*4 credits =24 Credits in 3 Year / 4 Year programme.
9. IL1 & IL2 should be of same language (In future other languages would be offered as an option in 2nd year).
10. Major and Minor selection will be at semester I based on:
 - The merit of the student & reservation policy of the Govt
 - Seat availability

(The faculty guidelines for the major and minor subject selection criteria would be followed)
11. Credit aligned with each course in major/minor and MDC is kept at 4 credits.
12. 5% of the total 132 credits would be IKS as per the UGC guidelines of March 2023.
13. **The University reserves the right to offer Fourth Year.**

Salient Points:

- Entry level eligibility:** The general category for entry into Level 4.5 is the Secondary School leaving certificate obtained after successfully completing Standard 12. A programme of study leading to entry into the first year of the Bachelor's degree is open to those students who have met the admission requirements as given in the faculty guidelines and GOG reservation Policy will be in place
- A student seeking admission in faculty of family and community sciences will have to register for academic bank credit and have his/her own ID to facilitate mobility of students. This is a formal system of credit recognition, credit accumulation, credit transfers and credit redemption to promote distributed teaching-learning from various recognized institutions, approved ODL and other sources to increase their knowledge, capacities and skills.
- Number of hours of a credit course shall be defined by its component of lecture and practical.
- Every student shall study "Environmental Science", "Sustainable Development Goals" and "Indian Knowledge System from the Family and Community Science Perspective" courses in I and II semester. The AEC would be English which would be spread over 4 semesters of 2 credit each.
- Design of Degrees:** Students shall be able to choose their major and minor depending on their needs, choice and requirement.
- A student who pursues three years undergraduate degree programme in a specific discipline as a Core course [for example, B.Sc. (any other discipline)] will earn 68

credits in that discipline and shall be awarded degree in that discipline, if s/he exits after completion of VI semester.

7. Only those students who get a **CGPA of 7.5 and above** will qualify for the fourth year of the Honours Programme.
8. If a student wishes to pursue four years Honours Degree with research, s/he shall compulsorily do an Advanced Research Methodology course.
9. Dissertation in the 4th year shall commence from VII semester and conclude in VIII semester.
10. Dissertation will be written in the Major Discipline with 12 credits.
11. Only a student mentioned at (5) & (6) above who opts to write a dissertation in the Major/Minor subject in VII and VIII semesters in the fourth year, shall be awarded 'Bachelor of Field of Study/Discipline (Honours with Research) in Discipline'. For instance, a student who pursues B.Sc. (Honours) in XXXX and writes a dissertation on a topic relating to XXXX shall be awarded 'Bachelor of Science (Honours with Research) XXXX. Major and Minor shall be indicated on fulfilment of the conditions mentioned earlier.
12. A student who pursues four-year undergraduate degree programme without research shall be awarded after completion of the VIII semester as degree as 'Bachelor of Field of Study/Discipline (Honours without Research)' on completion of the 12 credits of On-the-Job Training
13. The course code, number of credits, components of lecture, and practical, pre-requisites to be fulfilled for choosing that course and the department offering the course shall be spelt out for each course. A student should fulfil the pre-requisites of a course to be able to opt it for study.
14. A student can also accumulate fixed proportion (40%) of credits from approved ODL Courses as per UGC Norms.

Exit Options: Students are required to earn 22 credits per semester or 44 credits per year. The mandatory number of credits have to be secured for the purpose of award of Undergraduate Certificate/ Undergraduate Diploma/ Appropriate Bachelor's Degree in the field of Study, to a student who chooses to exit at the end of even semesters (Table 3).

ESTABLISHING MULTIPLE ENTRY & MULTIPLE EXIT (ME-ME) PATHWAY

The student shall enter and exit the educational ecosystem at any point of time from the degree program. There are due weightage given to the work experience gained or any other training undertaken by the student. The equivalency of credits will be calculated as per NCrf defined framework. However, the regulatory body shall prescribe the criteria for ME-ME options are as below:

- UG certificate after completing one year in a discipline or field including vocational or professional areas after securing minimum 44 credits provided they secure 4 additional credits in work based vocational skill course or internship/Apprenticeship offered (Exit courses) during summer vacation.
- UG Diploma after completing two years in a discipline or field including vocational or professional areas after securing minimum 88 credits provided they secure 4 additional credits in work based vocational skill course or internship/Apprenticeship offered (Exit courses) during summer vacation.
- UG Bachelor's degree after three years programme in the relevant discipline after securing minimum 132 credits in the relevant discipline.
- Exit options shall be provided with UG certificates, UG Diploma, UG Bachelor's degree to the student at the end of second, fourth and sixth semester respectively. In the fourth year, students will receive a UG Bachelor's degree (Honours/Honours with Research) after securing minimum 176 credits on successfully completion of all eight

semesters of the UG programme either at a stretch or with exits or re-entry options.

- Four Year UG Degree (Honours with Research): students who secure aggregate 75% & above marks in first six semester shall have the option to choose a research stream in fourth year. They have to do a research project under guidance of concerned HEIs with weightage of minimum 12 credits.
- Re-entry or lateral entry: Students who are opting for exit at any level, shall re-enter the programmes where they had left off. They can re-enter either in same or in different HEIs within three years of exit and complete the degree programme within the stipulated maximum period of seven years from the date of admission to first year UG programme.
- Inter University Transfer will be based on the Standard Operating Procedure (SOP) developed by Government of Gujarat.
- Summer Internship of 4 credits (one month) is mandatory for students who exit at the end of 1st year to get the Undergraduate Certificate.

Note: A student who wishes to continue with the progression of the programme will be governed by the ordinances of the University.

CONCLUDING REMARKS

The Undergraduate Curriculum Framework 2023 has taken into consideration several aspects and provides a holistic education with multidisciplinary approach. The students should make use of the flexibility that is provided to its optimum use. The new curriculum developed is an important footstep to bring out the transformational change in the education with the focus on employment opportunities. The students should make use of the flexibility with vigorous curriculum framework which would help them develop the required skills for various developmental tasks at Local, Regional, National and Global level.

DEPARTMENT OF CLOTHING AND TEXTILES

Head of the Department: Prof. (Dr.) Madhu Sharan

The Department of Clothing and Textiles has a rich history spanning over seven decades, with its inception in 1957. Initially, the department offered a four year undergraduate program, B.Sc. (Home) in Clothing and Textiles. Over the years, the department has expanded its academic offerings to include:

- M.Sc. (Home) postgraduate program (established in 1962)
- Ph.D. program (introduced in 1969)
- M.Phil. program (launched in 1995, but currently not offered)

In response to the evolving demands of the industry and keeping in tune with the trend, the department introduced a three-year vocational undergraduate degree in Fashion Designing in 2003-04, with initial funding for five years. This program was later integrated as a regular offering within the department. In 2023-24, with the introduction of National Education Policy 2020 and its gradual implementation underway, a four-year undergraduate program with multiple exits and multiple entries has been introduced with and without research options in the fourth year.

- B.Sc. (Honours) Fashion Designing (2023- under NEP 2020)
- M.Sc. (Honours) Clothing and Textiles (2023- under NEP 2020)

ELIGIBILITY CRITERIA FOR B.Sc. (F.C.Sc.) (HONOURS) IN CLOTHING AND TEXTILES / FASHION DESIGNING PROGRAMME

The following shall be considered eligible for admission to 4 years B.Sc. (F.C.Sc.) (Honours) programme in Clothing and Textiles / Fashion Designing:

- A candidate who has successfully passed the Higher Secondary (12th) Examination with English as a mandatory subject from a recognized board (CBSE/ICSE/IB/SB), in the academic discipline of Arts / Science / Commerce / Home Science.
- A candidate holding a three-year Diploma certificate from Gujarat Technological University (GTU) in Computer aided Costume Design and Dress Making / Textile Designing / Textile Manufacturing Technology with English as one of the subjects.

ELIGIBILITY CRITERIA FOR M.Sc. (F.C.Sc.) CLOTHING AND TEXTILES PROGRAMME

The candidate holding a Bachelor's degree in any of the following disciplines from The Maharaja Sayajirao University of Baroda or any other recognized university or recognized institution, shall be considered eligible for admission to M.Sc. (F.C.Sc.) Clothing and Textiles.

- B.Sc./BA with specialization in Clothing and Textile / Fashion Designing / Fashion Technology
- B.Sc. /B.A. Composite with Clothing and Textile as a subject.
- B. (Tech) with specialization in Textile Chemistry/Textile Technology.

Students seeking admission should possess a minimum of 55% marks at the last qualifying exam. The eligible candidates would be given admission based on a written test which would be conducted by the departmental admission committee.

Students who have not done the following courses at the undergraduate level, would be required to complete those additional courses along with the 88 credits of the Master's programme of the department as the pre-requisites:

- Fabric Manufacture and Design
- Dyeing and Printing of Textiles
- Textile Science
- Textile Testing
- Draping

- M.A. in Fine Arts with Fashion Design / Textile Design

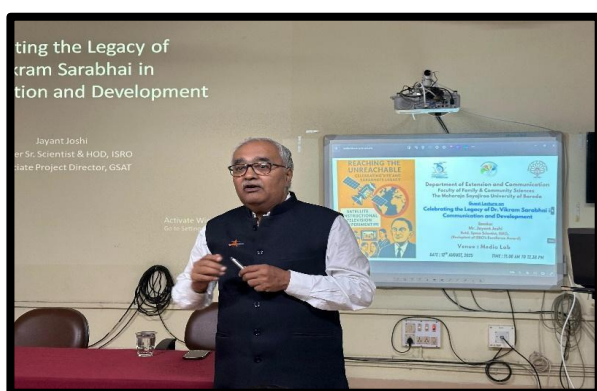

The Department of Family and Community Resource Management (FCRM), formerly known as the Department of Home Management, is one of the pioneer departments in India offering specialization at the undergraduate, postgraduate, and doctoral levels. The department offers two specializations at the undergraduate level: (i) Interior Design and (ii) Hospitality Management

At the postgraduate level, the department offers two specializations (i) Interior Design and (ii) Hospitality and Resource Management. The department also offers Ph.D. programme with specialization in Family and Community Resource Management.

To strengthen vocational education, the department has introduced several career-oriented programmes. In the academic year 2015–2016, it introduced Honours Degree Programme in Interior Design. From the academic year 2026–2027, the department offers the Post Graduate Diploma in Interior Design under the banner of the Department of Family and Community Resource Management. Further, in the academic year 2023–2024, the Four-Year Undergraduate Programme (FYUGP) was implemented in accordance with the National Education Policy (NEP) 2020, offering two specializations: Interior Design and Hospitality Management.

The department has also established "आत्मश्रित" – Vocational Skill Development Centre, which was inaugurated on 28th December 2023 in the Department of Family and Community Resource Management. This specialized centre conducts skill development activities for students as well as various community groups. It organizes workshops, demonstrations, and training programmes related to the hospitality industry and interior design. A wide range of activities and workshops have been conducted in areas such as kitchen gardening, vegetable carving, floral arrangements and décor, home décor accessories, garden furniture and accessories, front office management, and many more.

The centre also houses a Household Equipment Museum, which displays a diverse collection of utensils, crockery, and household equipment made from different materials, showcasing their historical and functional significance. In addition, the department has developed a kitchen

garden adjacent to the Vocational Skill Development Centre, providing practical learning opportunities and promoting sustainable practices.

The candidates can also apply for the University Research Fellowship awarded by The Maharaja Sayajirao University of Baroda. In addition, the department has projects from time to time, which can also make financial aid available to those who register for Ph.D. on topics related to the project work.

Scheme of Examination: Submission of the dissertation is followed by a viva-voce examination.

COURSE-WORK: CREDIT REQUIREMENTS

- The coursework shall be treated as a prerequisite for the award of Ph.D. degree. All research scholars admitted to the Ph.D. Programme shall be required to complete the coursework prescribed by the University/ Faculty/Department during the initial one or two semesters.

The Forum runs from 2021 to 2030 and addresses a critical gap in the field of diabetes by creating a dedicated space for WHO and Forum members to exchange ideas, share information, and align on key priorities. The Department was recognized as a Centre of Excellence by the Ministry of Health and Family Welfare in 1984 and held the prestigious status of a WHO Collaborating Centre for nearly two decades in important areas such as Anaemia Control, Weaning Technology, Maternal and Child Health Nutrition and Diet-Related Non-Communicable Diseases. The Department's mission is closely aligned with this global vision through its Campus-to-Community model, which promotes inclusive and equitable health, recognizes nutritional care as a right and supports low-cost dietary interventions to reduce the burden of diabetes, non-communicable diseases and other nutrition-related disorders. With strong research thrusts in clinical nutrition, public health nutrition, functional food product development, food safety, food quality, nutrition programmes, food environments and sustainable food systems, the Department actively nurtures competent professionals, researchers and socially responsive change-makers for healthcare, academia, industry and community development.

The Department's Nutrition Counselling Centre, established in 2013, is a Campus-to-Community initiative providing free, evidence-based nutrition assessment and counselling to students, staff and citizens of Vadodara. Its services include dietary assessment, counselling for diabetes, maternal and child nutrition, adolescent nutrition, sports nutrition, geriatric nutrition, nutrition in health and disease, and guidance for specially challenged groups. The Centre also promotes health awareness through camps, workshops and observance of important nutrition and health days. It functions every Thursday to Saturday from 1:00 pm to 4:00 pm at the Nutrition Counselling Center, Department premises.

To create world class committed public health, dietetics, nutrition and food science professionals who can contribute meaningfully to the social, economic and health development of the country.

MISSION

Persistently update and enrich the curriculum, conduct research in ongoing and emerging areas of nutrition and partner with various stakeholders to improve nutrition outcomes of the Indian population through evidence-based advocacy and national program implementation.

CAREER OPPORTUNITIES

The academic programmes of the Department of Foods and Nutrition are thoughtfully designed to equip students with the knowledge, skills and professional competencies required for careers in Nutrition and Dietetics, Food Science and Quality Control, Public Health Nutrition, Food Service Management and allied health and food sectors. The curriculum builds a strong foundation in basic sciences, foods and nutrition, human physiology and research methods, followed by advanced application-based learning in the respective areas of specialization. Core courses are progressively strengthened through practical training, clinical postings, community-based projects, industrial exposure, internships and on-the-job training, making students professionally competent and job-ready.

Graduates of Bachelor in Nutrition and Dietetics and postgraduate specialization in Dietetics can pursue careers as clinical dietitians, registered dietitians, clinical researchers, nutrition counsellors, wellness consultants, food service managers and academicians in hospitals, schools, workplaces, wellness centres and healthcare settings. Students specializing in Food Science and Quality Control are prepared for opportunities in food product development,

quality assurance, food safety, regulatory compliance, food testing laboratories, food industries and allied sectors. Public Health Nutrition graduates are prepared for roles as programme implementers, managers, researchers and policy-support professionals in government, non-government, CSR and international organizations such as WHO, UNICEF, WFP and GAIN.

ELIGIBILITY CRITERIA FOR BACHELOR IN NUTRITION AND DIETETICS (HONOURS) GRANT-IN-AID PROGRAMME

For admission to the **Bachelor in Nutrition and Dietetics (Honours)** programme, the applicant should have passed **Senior Secondary Examination (10+2)** or equivalent with **Physics, Chemistry and Biology**, securing a minimum of **50% marks**, with **English as one of the subjects**. The applicant should have completed **17 years of age** at the time of admission, or should complete 17 years on or before 31st December of the year of admission. Admission shall be granted on the basis of **Senior Secondary (10+2) merit**, as per Government of Gujarat reservation policy and University norms. A medical fitness certificate endorsed by a Government Medical Officer shall be required at the time of admission.

ELIGIBILITY CRITERIA FOR B. Sc. (F.C.Sc.) (Honours) GRANT-IN-AID AND HIGHER PAYMENT PROGRAMMES

For admission to the B.Sc. (F.C.Sc.) (Honours) Grant-in-Aid programmes in Food Science and Quality Control and Public Health Nutrition and the B.Sc. (F.C.Sc.) (Honours) Higher Payment Programme in Foods and Nutrition, the applicant should have passed the Higher Secondary Certificate Examination (H.Sc./10+2) or an equivalent examination from a recognized board, with English as one of the subjects. Applicants who have passed S.S.C. along with a minimum two-year diploma programme, with English as one of the subjects, shall also be eligible. The programmes are open to both male and female candidates fulfilling the prescribed educational qualifications. Admission shall be granted on the basis of merit, as per University and Government norms.

- c) B.F.C.Sc./ B.Sc. (Vocational) with specialization in Foods Science and Quality Control or Clinical Nutrition and Dietetics.

d) Where Foods and Nutrition is not clearly mentioned in the qualifying as major UG degree the following criteria should be met for eligibility.

a. Biochemistry along with 01 paper in each of the following areas.

(1) PHN/Community Nutrition

(2) Human Nutrition

(3) Dietetics

(4) Food Science & Nutrition

e) B.F.C.Sc./B.Sc. as in above a or P.G. Diploma in Dietetics, P G Diploma in Applied Nutrition, P G Diploma in Food Service Management & P G Diploma in Public Health Nutrition from a recognized institution.

f) Students graduated from 'Open Universities' recognized by University Grants Commission.

g) Students scoring a minimum of 55% marks in the last qualifying exam i.e. UG / P G Diploma are eligible to apply for M.Sc. in Foods and Nutrition (Dietetics / PHN) degree program. Relaxation of 5% will be given to SC/ST category.

h) Students with a 4-year Honours/Research degree as approved above can also enter the 2-year program or opt for a 1-year Master's. Students may exit after the first year with a Postgraduate Diploma, provided they fulfill the required credits.

i) The final selection would be based on the following criteria:

a) Marks/grades obtained at the qualifying examinations (50%)

b) Entrance examination (50%)

j) All India Merit list will be prepared based on the above-mentioned criteria along with GOG roster Guidelines.

ELIGIBILITY CRITERIA FOR POST GRADUATE DIPLOMA IN FOOD SERVICE MANAGEMENT

Candidates seeking admission to one year Post Graduate Diploma in Food Service Management must be graduates from any discipline from UGC Recognized University or National open university with English as one of the subjects.

ELIGIBILITY CRITERIA FOR Ph.D. IN FOODS AND NUTRITION PROGRAMME

Candidates holding a Master's Degree/Postgraduate Degree in Foods and Nutrition or in a related/allied subject from this University or any other recognized University/Institution shall

be eligible to apply for the Ph.D. Programme in Foods and Nutrition, provided they have secured a minimum of 55% marks in aggregate or its equivalent grade. Foreign candidates sponsored by their Embassies and other sponsored candidates shall also be eligible as per University norms. A relaxation of 5% marks shall be applicable for candidates belonging to EWS/SC/ST/SEBC-OBC Non-creamy layer/Differently-abled and other categories as per Government/University rules. As per NEP (2020) Candidates with a Four-year/Eight-semester Bachelor's Degree with Research shall be eligible with a minimum of 75% marks, as per University Ph.D. regulations. (Ref. No. R/MSU/ACA/331, dated 13/03/2026)

In addition to fulfilling the above academic requirements, the candidate should have qualified any one of the recognized eligibility tests conducted by statutory bodies, such as UGC-CSIR/ NET/ GSET/ GATE /GPAT/ DBT/ ICMR/ ICAR/ NBHM/ CEED/ DST-INSPIRE, or the Ph.D. Entrance Test of The Maharaja Sayajirao University of Baroda, namely MSU-PET/MSU-EPET, in the concerned subject. The NCAHP Act, 2021 was enacted to regulate and maintain standards of education and services for allied and healthcare professionals, assess institutions, maintain Central and State Registers, and promote research, development and adoption of scientific advancements in healthcare.

The Nutrition and Dietetics course is guided by the Council of the National Commission for Allied and Healthcare Professions, Ministry of Health and Family Welfare, Government of

India. It follows a competency-based curriculum designed to prepare qualified nutrition and dietetics professionals through strong academic, practical, clinical and research-based training.

The programme aims to develop competent professionals in Nutrition and Dietetics through a strong foundation in food science, human nutrition, anatomy and physiology, biochemistry, public health nutrition, medical nutrition therapy, food safety, nutrition counselling, research and professional practice. Students are trained to assess nutritional status, identify nutrition-related risk factors, plan balanced and therapeutic diets, provide nutrition and dietetic care, communicate effectively with patients and healthcare teams, and support health promotion across individual, group and community settings. The programme includes hands-on practical training, hospital-based clinical exposure, internship in defined clinical settings and a research project with structured evaluation.

The curriculum also introduces national and international food standards, regulatory requirements and contemporary food industry practices. Through hands-on laboratory training, industrial exposure, factory visits, internships and research-based learning, students connect theory with real-world applications. The specialization strengthens critical thinking, problem-solving, entrepreneurship and innovation, preparing graduates for careers in food product development, quality assurance, food safety, R&D, regulatory compliance, food testing laboratories, food processing industries, academics and allied sectors.

B. Sc. (F.C.Sc.) (HONOURS) PUBLIC HEALTH NUTRITION (GRANT IN AID) (NEP)

This specialization offers a comprehensive understanding of the interconnections between food systems, nutrition, health and community development. The courses are designed to help students identify key public health nutrition challenges, dietary risk factors and nutrition-related disease burdens at local, national and global levels. Students will develop competencies in nutrition programmes, epidemiology, research methods and interpretation of public health nutrition data to assess community needs and evaluate the reach, effectiveness and impact of ongoing health and nutrition interventions. The curriculum emphasizes national food and nutrition priorities, including flagship government programmes, their goals, objectives and target groups. Community internship exposure and field placements provide hands-on learning of real-world challenges and implementation barriers. Students also gain skills in nutrition communication; behaviour change strategies and development of educational materials for promoting healthier communities.

B. Sc. (HONOURS) FOODS AND NUTRITION (HIGHER PAYMENT PROGRAM)

This B.Sc. (Honours) Foods and Nutrition programme is a consolidated programme providing a holistic and multidisciplinary understanding of nutrition and dietetics, public health nutrition and food science and quality control. It is especially important in the present context, where lifestyle disorders, malnutrition, food safety concerns and the need for healthier diets are increasing across all age groups. The curriculum equips students to assess nutritional status across the life cycle, understand nutrient functions, metabolism, food sources and physiological systems and apply this knowledge in meal planning, dietetics and health promotion. Students gain foundational exposure to nutritional science, clinical nutrition, public health nutrition, food science and community nutrition programmes. The programme also emphasizes national food and nutrition priorities, government health initiatives, field placements and real-world implementation challenges. With skill-enhancing multidisciplinary courses, practical hands-on training, internships/on-the-job training and research exposure, students develop critical thinking, data interpretation and problem-solving abilities. The programme prepares graduates for opportunities in hospitals, research institutions, food and beverage industries, government sectors, entrepreneurship and community health settings.

With ICT-enabled learning, internship exposure and strong research orientation, the programme prepares graduates for careers as clinical dietitians, registered dietitians, research officers, sports nutritionists, freelance diet consultants, entrepreneurs and academicians, capable of promoting positive health outcomes across individuals, communities and population groups.

M. Sc. (F.C.Sc.) PUBLIC HEALTH NUTRITION (NEP)

The M.Sc. programme in Public Health Nutrition is designed to prepare skilled professionals who can address nutrition and health challenges at community, national and global levels. The programme builds advanced knowledge in nutrition programmes, epidemiology, food systems, dietary risks, research methods, health promotion and programme evaluation. It trains students to analyse population-level nutrition, health, dietary and epidemiological data, identify gaps in service delivery and assess the effectiveness of public health nutrition policies, interventions and flagship government programmes.

A major strength of the programme is its community internship component, where students gain supervised field exposure with government agencies, UN organizations, international and national NGOs, training institutes and development sectors. The research component enables students to undertake original or operations research in public health nutrition, strengthening evidence-based planning and decision-making. Graduates are prepared for meaningful roles as nutrition officers, programme managers, policy researchers, CSR nutrition executives, community development professionals, academicians and health-sector professionals contributing to healthier communities.

COURSES OFFERED AT DOCTORATE LEVEL

The Department of Foods and Nutrition offers a stimulating research environment in which students can pursue a Ph.D. degree from a wide variety of research themes. The doctoral program in Foods and Nutrition offers opportunities for advanced study and original investigations in basic and applied nutrition. The curriculum has been designed with both coursework and thesis research through laboratory and/or field work in a variety of areas relevant to foods and nutrition. Graduates are expected to take up leadership positions in academia, government, industry and private sector enterprises at national and international levels and to further knowledge in foods and nutrition through research and promote the application of such knowledge through public health policies and programs.

Financial Assistance: Candidates are advised to apply directly to various national bodies like SHODH fellowship (KCG), UGC, ICSSR and ICAR which offer junior research fellowships to doctoral students. The candidates can also apply for the University Research Fellowship awarded by The Maharaja Sayajirao University of Baroda. In addition, the department has projects from time to time, which can also make financial aid available to those who register for Ph.D. on topics related to the project work.

- The coursework shall be treated as a prerequisite for the award of Ph.D. degree. All research scholars admitted to the Ph.D. Programme shall be required to complete the coursework prescribed by the University/ Faculty/Department during the initial one or two semesters.
- The credits assigned to the Ph.D. coursework shall be 12 credits.

DEPARTMENT OF HUMAN DEVELOPMENT AND FAMILY STUDIES

Head of the Department: Prof. (Dr.) Rachana Bhangaokar

The Department of Human Development and Family Studies (HDFS) at The Maharaja Sayajirao University of Baroda was founded in 1949 and is India's pioneering institution in this discipline. Human Development and Family Studies (HDFS) is an interdisciplinary field that focuses on the development of individuals across the life span in the context of family and society. In order to gain a comprehensive understanding of development, the field draws from diverse disciplines such as Biology, Physiology, Anthropology, Education, Philosophy and Sociology. The understanding thus gained is applied to further the quality of life of individuals, families and communities. The Department was awarded the status of Centre of Advanced Study in Human Development and Family Studies by the University Grants Commission (UGC) in 2003 and completed 3 phases of the CAS program in 2022. With support from the University Grants Commission (UGC) and research funds from other national and international agencies, the department continues to strengthen its academic, research, and community outreach programs.

Chetan Balwadi - The Laboratory Nursery School

Established in 1949, Chetan Balwadi is a laboratory nursery school of the Department of Human Development and Family Studies. It serves as a laboratory for students of the Department at the undergraduate and postgraduate levels and is a vibrant training centre for students enrolled in the Postgraduate Diploma Program in ECCE. Chetan Balwadi offers a three-year preschool program aimed at providing enriched opportunities for the holistic development of each child. The main facets of Chetan Balwadi include a high-quality Early Child Development program for children, firmly rooted in the Indian cultural context; training of professional and paraprofessional personnel; and research and advocacy. The program is activity-based, encouraging exploration of the environment, opportunities for self-expression and hands-on concrete experiences within a meaningful context. Active involvement of parents as partners in the process of education and child development is emphasised, and over the years, an active Parent- Teacher Association has strengthened the program.

CAREER OPPORTUNITIES

A variety of career options are available, spanning the domains of teaching, research, consultancies and involvement in non-government and government organisations, both national and international. A degree in Human Development and Family Studies also opens new avenues for further professional development across fields such as Social Work, Government, Non-Government, and Corporate Social Responsibility (CSR). The Master's Degree in Human Development and Family Studies includes a life span approach. This gives students immense opportunities to develop substantial skill sets for working across various settings throughout the lifespan. It also focuses on rigorous learning of research and provides hands-on experience of management, leadership and supervision in the field. Some of the positions held by former students include - principals, curriculum developers, supervisors and teachers in schools/ preschools. In addition to education, students have also secured positions in NGOs, research firms or the health care sector.

Many of our students have paved their own path by becoming consultants, corporate trainers, and entrepreneurs in the field of child development, child rights, community development, education and pursue further education in ECCE and Human Development programs abroad and are teaching and practicing in many countries globally, to name a few. The program prepares students to design holistic human interventions rooted in theory and emerging societal needs, for example, issues related to the elderly and gerontology.

ELIGIBILITY CRITERIA FOR B. Sc. (F.C.Sc.) (HONOURS) HUMAN DEVELOPMENT AND FAMILY STUDIES PROGRAMME

The educational qualification of the candidate seeking admission in the B.S. Programme should be a minimum of 10+2 pass with English as a compulsory subject or should have studied through English as a medium of instruction. Admissions are open to both male and female candidates who meet the required educational qualifications. Admission will be granted based on merit.

ELIGIBILITY CRITERIA FOR M. Sc. (F.C.Sc.) HUMAN DEVELOPMENT AND FAMILY STUDIES PROGRAMME

For admission to M.Sc. (Family and Community Sciences) degree program in Human Development Family Studies, a student must have completed B.Sc. Degree in Human Development and Family Studies/Child Development or Bachelor's degree in Sociology/Psychology/Education (not B.Ed.)/Social Work or B. Sc. (Gen.) or B.Sc. /B.A. Degree with General Home Science with minimum of 55% and above at the last qualifying exam.

ELIGIBILITY CRITERIA FOR POST GRADUATE DIPLOMA IN EARLY CHILDHOOD CARE AND EDUCATION (ECCE)

B. Sc. / B.A. / Graduate in any Discipline

To be eligible to seek admission in the Post Graduate Diploma Program in Early Childhood Care and Education the candidate should have a graduate degree in any discipline with

minimum of 50% and above at the last qualifying exam. Preference is given to candidates who have graduated with Home Science subjects. Over and above this, work experience in the field of Early Childhood Care and Education is considered favorably. The candidates are short-listed on the basis of candidate's merit at graduate level.

The Center undertakes multifaceted activities of research, teaching, training, documentation, and community outreach programs from the standpoint of women's lived experiences with the aim to create critical consciousness about gender in the socio-political, economic and cultural order. The primary objective of WSRC is to open up windows to gender equality and equity, in order to develop, promote and disseminate knowledge about women's and gender issues in the society.

WSRC organizes teaching and training programs to incorporate the gender perspective in mainstream disciplines through courses, seminars, workshops and curriculum development programs across different departments of the University, other universities, research centers, NGOs and allied institutes. Choice based courses are offered to undergraduate students of the Faculty to instill a gender perspective. WSRC also conducts regular sessions on Gender Sensitivity and Prevention of Sexual Harassment for students across different departments and Faculties of the University.

WSRC has been conferred the Federation of Gujarat Industries (FGI) Award for Excellence in the category of '**Outstanding Achievement in the field of Woman/Girl Child Welfare and Empowerment**' in 2009.

SCHOLARSHIPS

1. Kelwani Trust Fund Scholarship

Awarded every semester based on previous semester academic record. Two Scholarships of rupees 50.00 each per semester are awarded in each of the academic years of the three year B.Sc. (F.C.Sc.), programme. If more students than one are placed at the first and second ranks the scholarship amount is shared amongst such students.

2. Smt. Manigauri Biharilal Kantawala Memorial Scholarship

Smt. Manipuri Biharilal Kantawala Memorial Scholarship is awarded to a student specializing in Home Management who passes the B.Sc. (F.C.Sc.), Degree examination of the Maharaja Sayajirao University of Baroda at the first attempt securing the highest-grade point and pursuing further studies leading to Master's Degree specializing in Home Management in the Faculty of Family and Community Sciences.

3. Prof. (Dr.) Arvinda Chandra Scholarship

Prof. (Dr.) Arvinda Chandra Merit Scholarships will be awarded to two regular students of the third year B.Sc. (F.C.Sc.), in the Department of Extension and Communication, Faculty of Family and Community Sciences, The Maharaja Sayajirao University of Baroda. The scholarship will be given to the first and second ranking students, found on the basis of their AGP, at least “B” grade in the second year of the Department.

4. Prof. Justina A. Singh Memorial Scholarship

Prof. Justina A. Singh Memorial scholarship will be awarded to a regular candidate securing the highest-grade point at the B.Sc. (F.C.Sc.) Examination held by The Maharaja Sayajirao University of Baroda in March/April specializing in Clothing and Textile in the first attempt with minimum A grade.

5. Eklavya Scholarship in Excellence

Instituted by the Eklavya Education Foundation, Ahmedabad it is awarded to B.Sc. (F.C.Sc.), and P.G. ECCE students of the Department of HDFS excelling in academics.

6. Prof. Ms. P.S. Chari Merit Scholarship

Prof. Ms. P.S. Chari Merit Scholarship is awarded to a student admitted to M.Sc. (F.C.Sc) degree programme in Faculty of Family and Community Sciences, the Maharaja Sayajirao University of Baroda, on successful completion of B.Sc. (F.C.Sc) Degree Examination in March/April of any recognized university of India with specialization in Extension and Communication scoring the highest marks/grade point from amongst such students, obtaining a minimum “B” grade at the first attempt at the B.Sc. (F.C.Sc) Degree Examination.

7. Pramila Phatak Post Graduate Research Scholarship

This scholarship was instituted in 1975 in honor of Dr. Pramila Phatak, who retired from service after many fruitful years of work. Her contributions in the area of infant assessment have put the Department on the international map. The Pramila Phatak Scholarship is awarded once a year to a senior master’s (Sr. M.Sc.) student who has demonstrated competence in research.

8. Prince Dhairyashilrao Sayajirao Gaekwad Scholarship

Prince Dhairyashilrao Sayajirao Gaekwad Scholarship is awarded to a poor and deserving student in the second year of Master’s Degree programme in Human Development and Family Studies (HDFS) to cover tuition fees. Students who have secured a minimum „B” grade at the first year of Master’s Degree Programme and whose parents’ annual income does not exceed rupees 10, 000 are eligible to apply for the award of this scholarship.

9. Smt. Roma Mehta Ph. D Scholarship

Smt. Roma Mehta Ph.D. Scholarship is awarded to the student pursuing Ph.D. in Extension and Communication for financial assistance.

FREESHIPS

The number of students awarded free-ships in the Faculty of Family and Community Sciences is fixed at 15 percent of the total number of students.

Free-ships are awarded to students with weak economic backgrounds. Students desirous of securing free-ships should apply within the specified time on prescribed application form available at the Office of Faculty of Family and Community Sciences. Income certificate should accompany such an application.

The students would be selected for the award of free-ship after subjecting the applicants to an interview conducted by the committee appointed by the Dean. The selected candidates are required to maintain a certain minimum performance in academics every semester for continuation of free-ships in subsequent semesters.

1. Free-ships for Economically Backward Class

Those students who are from EBC category (as per note) will be exempted from giving the development charges. (The income limits of rupees 25, 000/- per year be considered as EBC category and a certificate to the effect is produced by the student duly obtained from mamlatdar at the time of paying fees. Ref. No. A/225 dtd.13.5.1999).

For the purposes of this award, income shall mean the sum total of the income from whatever source including share in joint family income and independent income of the students and their parents. The income specified shall be the income during the financial year preceding the year in which free-ship is sought.

Application for the award of this free-ship shall be made in duplicate every year in the prescribed form available at Vakil Printing Press along with income certificate duly endorsed by a Gazetted Officer or Sarpanch.

2. Free-ships/Scholarships for Scheduled Caste and Scheduled Tribes

Application for free-ships/scholarship shall be submitted to the Director, Social Welfare, Gujarat State, Ahmedabad, who awards these according to merit and income. Students belonging to SC/ST groups are awarded freeships, cost of books, examination fees and room rent concessions by the Social Welfare Officer of the District.

3. War Concession Free-ships

The Government of Gujarat awards war concession free-ship to students whose parents are in the defense and who have laid down their lives for the country in the war, on production of a certificate to this effect from proper authorities.

4. Poor Student's Aid Fund

Financial assistance from Student's Aid Funds is extended to deserving students on the basis of their need and merit to cover expenses on tuition fees, examination fees and/or purchase of books and/or equipment on their commendation of the authorities in the Faculty of Family and Community Sciences.

The students desirous of availing of this assistance should apply in the prescribed proforma available at the office of Faculty of Family and Community Sciences and submit the same duly filled in to the office in time.

GOLD MEDALS

1. Smt. Itchhagauri Naik Gold Medal

This is awarded to a student earning the highest quality point with a minimum "A" grade in class performance and the University Examination as per the guidelines worked out by the committee constituted by the Dean, Faculty of Family and Community Sciences.

2. The Vice Chancellor's Gold Medal

The Vice Chancellor's Gold Medal is awarded to the candidate securing the highest percentage of marks at the B.Sc. (F.C.Sc.) Degree Examination held by The Maharaja Sayajirao University of Baroda provided the candidate secures a minimum first class. This is awarded to students of different faculties by rotation.

3. Smt. Jasumatiben Nagrecha Gold Medal

Smt. Jasumatiben Nagrecha Gold Medal will be awarded to a student passing B.Sc. (F.C.Sc.) Final Degree examination held by The Maharaja Sayajirao University of Baroda in March/April with specialization in Extension and Communication obtaining highest quality point considering the last 4 semesters in the category of "A" grade at the first attempt.

4. Smt. Parvatiben Patel Gold Medal

Smt. Parvatiben Patel Gold Medal to be awarded from among all the M.Sc. (F.C.Sc.) Students belonging to all the specializations, to the student who has passed M.Sc. (F.C.Sc.) Degree examination in two years during regular academic year obtaining highest quality

points considering the courses of all the four semesters, obtaining minimum “A” grade at the first attempt.

In case of a tie between two or more students for securing equal aggregate points as per above rule the medal should be awarded to a student who has secured the highest grade in the M. Sc. (F.C.Sc) Final examination.

5. The Chancellor’s Gold Medal

The Chancellor’s Gold Medal is awarded to the candidate securing the highest percentage of marks at the M. Sc. (F.C.Sc) Degree examination held by The Maharaja Sayajirao University of Baroda provided the candidate secures a minimum first class. This is awarded to students belonging to different faculties by rotation.

6. Priya Modern Food Products, Baroda Gold Medal

Priya Modern Food Products, Baroda Gold Medal is to be awarded to a student who has passed M. Sc. (F.C.Sc.) Final Year in Foods and Nutrition with specialization in either Dietetics or Public Health Nutrition with First rank in the Degree Examination held by The Maharaja Sayajirao University of Baroda in March/April every year. This medal is awarded at the annual convocation from 1998 onwards.

7. Dr. Leela Shah Memorial Gold Medal

Dr. Leela Shah Memorial Gold Medal is awarded to candidate specializing in “Extension and Communication” passing the M.Sc. (F.C.Sc) Degree Examination held by The Maharaja Sayajirao University of Baroda in March/April securing the highest-grade point at the first attempt with a minimum “A” grade.

8. Smt. Chandanben Dahyabhai Inamdar Gold Medal

Smt. Chandanben Dahyabhai Inamdar Gold Medal is given to the regular student who has passed the B.Sc. (F.C.Sc) Final Degree examination with highest grade point in first attempt with specialization in Extension and Communication.

9. The C. Gopalan – Srikantia- Gold Medal

The C. Gopalan – Srikantia- Gold Medal is to be awarded to a regular post-graduate student at the Maharaja Sayajirao University of Baroda. The award will be for an outstanding post-graduate thesis/dissertation submitted in that academic year for a Masters degree in the area of (Foods and Nutrition) with specialization in Dietetics or Public Health Nutrition or any other specialized area of Biosciences e.g. Biochemistry, Biotechnology, Microbiology or Physiology for the dissertations/thesis related to Foods and Nutrition.

10. The Shantaben Gajanan Bhatt Gold Medal

This Gold Medal is awarded to an under graduate student who obtains first rank across all the semesters at the undergraduate level, B.Sc. (F.C.Sc.), in the Department of Human Development and Family Studies, Faculty of Family and Community Sciences in the examination held in March/April.

11. Smt. Kamalaben Jivanlal Parikh Gold Medal

Smt. Kamalaben Jivanlal Parikh Gold Medal is to be awarded to the candidate who has passed M.Sc. (F.C.Sc.) Examination held by the University of Barodain March/April at First attempt with specialization in Home Management obtaining the highest quality point with minimum “A” grade.

12. Prof. Sunanda Madhukar Phadke Gold Medal

Prof. Sunanda Madhukar Phadke Gold Medal is to be awarded to the candidate who has passed securing the highest aggregate grade at the B.Sc. (F.C. Sc). Degree examination held by The Maharaja Sayajirao University of Baroda in March/April with specialization in Clothing and Textile/Fashion Designing.

13. Mrs. Usha Cheema Gold Medal

Mrs. Usha Cheema Gold Medal is to be awarded to the candidate who has passed B. Sc. (F.C.Sc) with specialization in Clothing and Textiles held by The Maharaja Sayajirao University of Baroda in March/April in first attempt with no subject repeat in any subject and obtaining the highest cumulative grade point average (CGPA) with minimum A Grade.

14. Shri. Hirak Navalawala Trust Gold Medal

Shri. Hirak Navalawala Trust Gold Medal is to be awarded to the candidate who has passed M. Sc. (F.C.Sc.) Examination with specialization in Clothing and Textiles held by The Maharaja Sayajirao University of Baroda in March/April in first attempt with no subject repeat in any subject and obtaining the highest cumulative grade point average (CGPA) with minimum A Grade.

15. Prof. Veena Gandotra Gold Medal

Prof. Veena Gandotra Gold Medal is to be awarded to the candidate who has passed B.Sc. (F.C.Sc.) Examination with Home Management major passing with minimum “A” grade obtaining highest aggregate grade point in III, IV, V & VI semesters.

16. Late Smt. Jerbanu Nadirsaw Katpita Memorial Gold Medal

The Gold Medal is awarded at the Annual Convocation to be given to the candidate who

has passed Bachelor of Faculty of Family and Community Sciences (B. F.C.Sc.) Examination standing First in order to Merit. In case of a tie between two or more students for securing equal highest number of marks as per rule no.6 above, the amount of the Gold Medal shall be provided and distributed equally amongst all the students. In case the Gold Medal is not awarded in any year the amount of the interest shall be created to the corpus of the fund.

17. Smt. Chandanben Dahyabhai Inamdar Gold Medal

The Gold Medal is awarded at the Annual Convocation to be given to the candidate who has passed the highest grade point at Final B.Sc. (F.C.Sc.) in the Dept. of Extension & Communication at the Faculty of Family and Community Sciences examination in the first attempt with highest grade point/percentage of marks. In case of a tie between two or more students for securing the equal highest number of marks as per rules above, the Gold Medal shall be provided and distributed equally amongst all the students.

18. Dr. Sangeeta Chaudhary Memorial Gold Medal

The Gold Medal is awarded at the Annual Convocation to be given to the candidate who has secured the highest grade point in the final year of B.Sc. (F.C.Sc.) Degree in HDFS Department, Faculty of Family and Community Sciences. In case of a tie between two or more students for securing the equal highest number of marks as per rules no.6 the amount of the Gold Medal shall be provided and distributed equally amongst all the students.

19. Prof. Vanisha Nambiar Gold Medal

The Gold Medal is awarded at the Annual Convocation to the candidate who has passed M.Sc. (Public Health Nutrition) Degree Examination held by The Maharaja Sayajirao University of Baroda securing the highest cumulative grade point average with a minimum “A” grade. In case of a tie between two or more students for securing the equal highest number of marks as per the rules above the amount of the Gold Medal shall be provided and distributed equally amongst all the students.

20. Swati Elavia Gold Medal

The Gold Medal is awarded at the Annual Convocation to the candidate who has passed M.Sc. (Dietetics) Degree Examination held by The Maharaja Sayajirao University of Baroda securing the highest cumulative grade point average with a minimum “A” grade. In case of a tie between two or more students for securing equal highest number of marks as per the rules above the amount of the Gold Medal shall be provided and distributed equally amongst all the students.

21. Prof. Jayaprabha Patel Gold Medal

The Gold Medal is awarded at the Annual Convocation to the candidate who has passed B.Sc. Honours in Department of Foods and Nutrition (B.Sc. FN (Honours) HPP) Degree Examination held by The Maharaja Sayajirao University of Baroda securing the highest cumulative grade point average with a minimum “A” grade. In case of a tie between two or more students for securing the equal highest number of marks as per the rules above the amount of the Gold Medal shall be provided and distributed equally amongst all the students.

22. Vinodkant A. Sanghani Gold Medal

The Gold Medal is awarded at the Annual Convocation to the candidate who has passed B.Sc. (Dietetics) Degree Examination held by The Maharaja Sayajirao University of Baroda securing the highest cumulative grade point average with a minimum “A” grade. In case of a tie between two or more students for securing equal highest number of marks as per the rules above the amount of the Gold Medal shall be provided and distributed equally amongst all the students.

23. Tanay Janak Patel Gold Medal

The Gold Medal is awarded at the Annual Convocation to the candidate who has passed B.Sc. (Public Health Nutrition) Degree Examination held by The Maharaja Sayajirao University of Baroda securing the highest cumulative grade point average with a minimum “A” grade. In case of a tie between two or more students for securing the equal highest number of marks as per the rules above the amount of the Gold Medal shall be provided and distributed equally amongst all the students.

24. Prof. Subathra Seshadri for BSc (Honors) Food Science and Quality Control Gold Medal

The Gold Medal is awarded at the Annual Convocation to the candidate who has passed B.Sc. (Food Science and Quality Control) Degree Examination held by The Maharaja Sayajirao University of Baroda securing the highest cumulative grade point average with a minimum “A” grade.

25. University Gold Medal for Bachelor of Science (F.C.Sc.) (Honours)- Interior Design

The Gold Medal is awarded at the Annual Convocation to the candidate Who has passed the B.Sc. (F.C.Sc.) in Interior Design Examination with first class at first attempt with highest grade point.

26. University Gold Medal for Bachelor of Science (F.C.Sc.) (with credits)- Family and Community Resource Management [Interior Design]

The Gold Medal is awarded at the Annual Convocation to the candidate Who has passed the B.Sc. (F.C.Sc.) in Interior Design Examination with first class at first attempt with highest grade point.

27. University Gold Medal for Master of Science (F.C.Sc.) (with credits)- Family and Community Resource Management [Interior Design]

The Gold Medal is awarded at the Annual Convocation to the candidate Who has passed the M.Sc. (F.C.Sc.) in Interior Design Examination with first class at first attempt with highest grade point.

AWARDS / PRIZES

1. Smt. Ansuya Krishnamurthy Community Outreach Award

This award is given to a master's student who excels in fieldwork. It is named after Smt. Ansuya Krishnamurthy, who was associated as a preschool teacher with Chetan Balwadi, the laboratory nursery school of the Department, from its inception. It was initiated in 1995 by Prof. Parul Dave, an alumni achievement award. It is given to regular students of M.Sc. (F.C.Sc.) in Human Development and Family Studies at the end of the IVth semester. The student must have obtained a minimum of overall „B“ grade with minimum of ‘A’ grade in Field Work related courses.

2. The Alumni Achievement Award

This award seeks to recognize, encourage and promote the contribution of the alumni of the Department of Human Development Family Studies. Any significant contribution by way of action programs, research, seminars/workshops/training programs, publications, development of educational materials or any other related activity is selected for the award. In the nomination and selection of candidates for the award, the spirit in which the award was instituted is always kept in mind.

3. Prof. Amita Verma Prize

Prof. Amita Varma Prize is given to Postgraduate Diploma students of ECCE who secure first position. This award was initiated in 1998-99 by Ms. Nita Patel, herself an alumni achievement awardee, in honor of Prof. Amita Verma in recognition of her invaluable contribution to the genesis and growth of the Department.

4. Shri. Harilal Muljibhai Trivedi Prize

This prize is awarded to a P.G. ECCE student who scores highest in fieldwork, the prize was initiated in 1998-99 by Ms. Rajeshwari Trivedi, an alumni achievement award.

5. Rajbala Sharma Memorial Prize in Child Development

This prize was instituted by the Department in memory of late Ms. Rajbala Sharma, a master's student in Child Development, who endeared herself to the teachers and peers as a genuine seeker of knowledge. Her life was cut short in June 1979 following a major heart surgery. It is awarded to regular student of the Master's degree programme in Human Development and Family Studies (HDFS).

6. Shri. Jashvantlal Trikamlal Bumia Prize

Shri. Jashvantlal Trikamlal Bumia Prize is instituted in memory of Shri Jashvantlal Trikamlal Bumia and is to be awarded to the candidate specializing in Foods and Nutrition with any specialization, namely Public Health Nutrition/Dietetics/ Food Science & Quality Control securing the highest aggregate grade at B.Sc. (F.C.Sc.) (Honours) Degree Examination.

7. Prof. Kalpana Parlikar Prize

Prof. Kalpana Parlikar Prize is awarded every year to a top-ranking student with a minimum of "B" grade in the Post Graduate Diploma in Development Management offered by the Department of Extension and Communication.

8. Ms. Savitri Pandit Prize

Ms. Savitri Pandit Prize in cash is to be awarded to a regular student specializing in Clothing & Textiles passing the M.Sc. (F.C.Sc.) degree examination held by The Maharaja Sayajirao University of Baroda in March/April, securing the highest-grade point at the first attempt with a minimum "A" grade.

9. Smt. Maniben Ranchhodlal Shah Prize

Smt. Maniben Ranchhodlal Shah Prize in cash to be awarded to a student who has passed M. Sc. (F.C.Sc.) Degree in Foods and Nutrition with specialization in either Dietetics or Public Health Nutrition, securing the highest-grade point at the first attempt with a minimum "A" grade in the Degree Examination held by The Maharaja Sayajirao University of Baroda in March/April every year. The candidate should be recommended by the Head, Foods and Nutrition Department and Dean, Faculty of Family and Community Sciences.

10. Outstanding Student award (PG level) by MSUFNAA

Foods and Nutrition Alumni Association (FNAA) confers an outstanding student award to a M. Sc. student who has completed three semesters of study at the department. Nominations are invited from the students. The final name is decided following the criteria set up by the association.

11. Outstanding Student award (UG level) by MSUFNAA

Foods and Nutrition Alumni Association (FNAA) confers an outstanding student award to a B. Sc. student who has completed five semesters in the department. Nominations are invited from the students. The final name is decided Following the criteria set up by the association.

STUDENTS SUPPORT SYSTEM

VARIOUS COMMITTEES AT FACULTY LEVEL FOR STUDENT WELFARE

Dean, Faculty of Family and Community Sciences appoints teaching faculty members for each post to function as Students Coordinator, Sports Coordinator and Teacher supervisor. 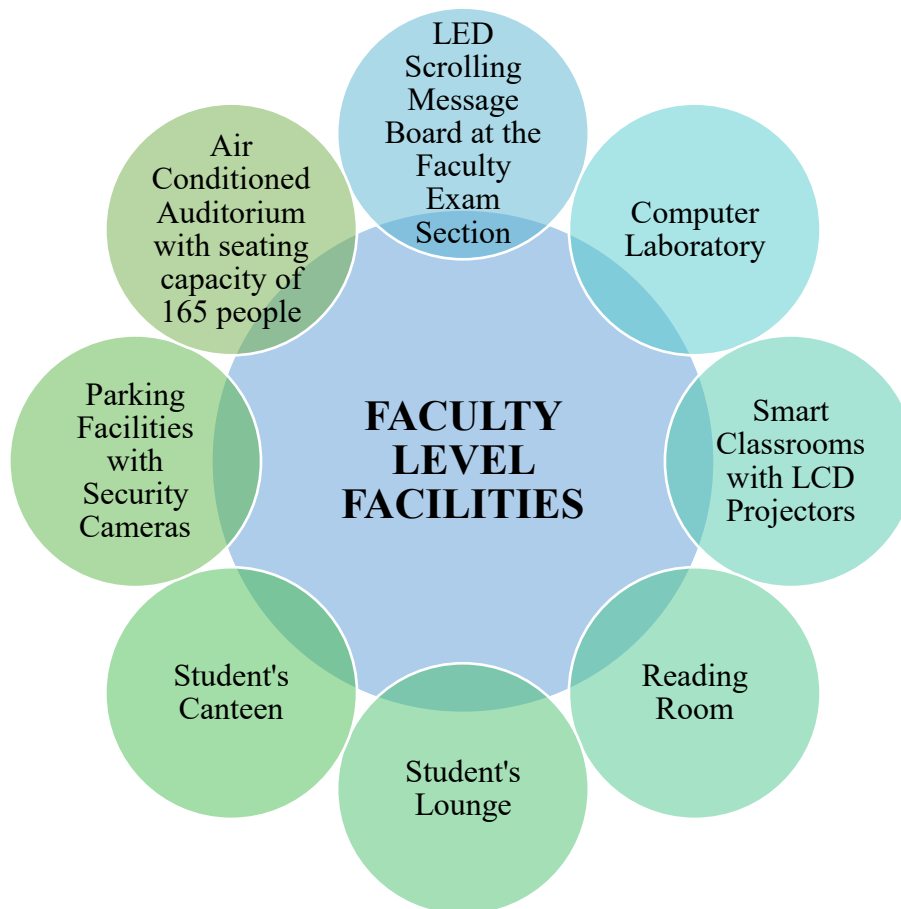
TEACHERS SUPERVISOR

GENERAL RESOURCES OFFERED BY THE MAHARAJA SAYAJIRAO UNIVERSITY OF BARODA

SMT. HANSA MEHTA LIBRARY

- Smt. Hansa Mehta Library, a state of art Library is the first in the state to provide Wi-Fi facility to its clientele. The library is under surveillance through a closed-circuit television with the help of 24 cameras located strategically around various functional areas.
- It has a rich collection of prescribed textbooks and bound journals of more than one lakh, out of which some are as old as Nineteenth Century available till date.
- The library has a digital collection of rare books in house to create an Institutional Repository to serve the readers globally.
- It has the single largest Reading Room of 10,600 sq. ft. which can accommodate about 1100 readers at a time and is open to readers from 8.00 am to 10.00 pm i.e. 14 hours a day throughout the year except National holidays.
- All reading area covered with fully central AC facility. It is situated in the whole North Side of the building, to have a continuous natural light throughout the year.
- The books are stacked on two floors. These Stack Rooms have the same dimensions as the Reading Room with an additional sitting capacity of 500 plus readers.
- To serve the visually challenged and people with low vision, Zoomed Instant Text Reader has been procured.

UNIVERSITY HEALTH CENTRE

- The University Health Centre provides consultation, investigations, specialists' services, treatment facilities for all common ailments, minor surgical treatment and counselling services to the staff, their dependents and students of The Maharaja Sayajirao University of Baroda.
- Facilities for admission under observation, administration of intravenous fluids, immunization services and supportive laboratory are also available.

MARG COUNSELING CENTRE AT THE UNIVERSITY HEALTH CENTRE

- Counselling, Psychotherapy, Psychiatric treatment and psychological testing are offered by MARG Counselling Centre, functioning at the University Health Centre on voluntary basis.
- It provides treatment in cases of mental health problems, stress and substance abuse to the University staff, their children and family members, as well as youths, school

children and general public of Vadodara.

HALLS OF RESIDENCE FOR BOYS AND GIRLS

- The Maharaja Sayajirao University of Baroda has one of the largest hostel campuses in Western India.
- 12 Boys Hostel and 4 Girls Hostel and a separate Hostel for SC/ST are spread over the area of approximately 100 acres accommodating approximately 3800 students.

UNION PAVILION GROUND

The Union Pavilion Ground has facilities like swimming pool, athletic track, badminton court, basketball court, tennis court, volleyball court, kho-kho court, handball court, hockey field, cricket field, football field, kabaddi court, indoor table tennis hall and multi gym maintained by the Department of Physical Education.

UNIVERSITY GUEST HOUSE

The University Guest House is located in the heart of the University Campus, just besides the Vice Chancellor's Bungalow. It provides comfortable facilities for staying on the campus. It has 30 rooms with different types of comforts.

UNIVERSITY STUDENT'S FACILITATION CENTRE

Student's Facilitation Centre serves as a help desk in The Maharaja Sayajirao University Main office to provide a one-point interface between students and university administration for information requirements, transactions related to examination and results, various issue of documents, payments for various services and purchase of publications. A helpline with videophone and well-informed staff member at the reception are the key aspects of the Centre.

The Centre for Lifelong Learning and Extension is active in the field of Continuing Education in and around Vadodara since the last four decades. The Centre offers short-term courses ranging from fifteen days to three months, and long-term courses ranging from six months to one year.
