Inviting Quotation for 'Online Legal Research Database'

Notice Inviting Quotations for Online Legal Research Database from reputed Firms/Companies etc. for procurement of Online Legal Research Database as per the Technical Specification mentioned in Annexure B. Interested vendors are requested to send their quotation as under:

1. Sealed quotations are invited for Online Legal Research Database for a period of One year from the date of subscription for Faculty of Law, The Maharaja Sayajirao University of Baroda, Vadodara.
2. Each Bidder shall submit ONLY ONE Quotation. In the Sealed Cover of Quotation, there shall be two different sealed covers, one for Technical Bid and other for Financial Bid. Each separate cover shall be super-scribed as "Technical Bid" and "Financial Bid".
3. The Technical Bid shall not contain any details regarding the price of the product.
4. Financial Bid Cover shall be opened only if the Technical Bid meets the required specifications as mentioned in Annexure B and should be valid for 3 months.
5. The rates quoted in the Financial Bid should be inclusive of GST.
6. Information as per Annexure A shall be submitted along with the Financial Quotation.
7. Rate should be inclusive of all services needed to access the product.
8. No change, alterations, addition etc. is permitted in the Quotations.
9. Unsigned Quotations will be rejected.
10. The Quotations shall be sent in a sealed cover super-scribed with words "Quotation" and be sent through Registered AD or Courier to OSD, Faculty of Law, The Maharaja Sayajirao University of Baroda, Sir Pratapsinhrao Gaekwad Parisar (Donor's Plaza), Opp. University Head Office, Fatehgunj, Vadodara- 390002. Gujarat on or before 2nd March 2023.
11. The Quotations will be opened on 4th March 2023 at 4.00 pm in the Office of The Dean, Faculty of Law. Interested parties may remain present.
12. The undersigned reserves the right to accept or reject the quotation and to cancel the bidding process and reject all quotations at any time prior to the award of Contract without assigning any reasons.
13. The access to the Services of the Database shall be made available within a period of One week from the date of confirming the Order.
14. Payment will be released after necessary approvals from the University Office and only after the access to Database has been received. No Advanced or part payment against the Quotation shall be given.
15. Disputes, if any shall be subjected to the jurisdiction of Vadodara, Gujarat.
