IMPORTANT INSTRUCTIONS

- Candidates whose names have been declared in the First Provisional Merit List are required to come in person and submit following documents in original along with one set of self-attested photo copy to the Faculty of Law Office from 25/6/24 to 29/6/24 between 11.30 am to 2.30 pm.
- LIST OF DOCUMENTS
 - 1) Print out of Application Form
 - 2) Zerox Copy Aadhar Card
 - 3) School Leaving Certificate
 - 4) Mark sheets: HSC(XII) (if applicable)
 - 5) All Marksheets of Graduation, if applicable
 - 6) All Marksheets of Law Graduation and Degree Certificate of Law Graduation
 - 7) Degree certificate of other Graduation, if applicable
 - 8) Migration Certificate for students from other than The Maharaja Sayajirao University of Baroda
 - 9) Caste Certificate, wherever applicable. The SC, ST and SEBC / OBC /EWS certificate issued by the Government of Gujarat is acceptable.

10) In addition to caste certificate the candidates belonging to SEBC category are required to submit latest non creamy-layer certificate in. (Parishisth - Ka).

11) Two Passport Size Photographs.

Further, the following documents would also be required:

1. Thalassemia Report
2. Undertaking pertaining to Anti-Ragging Measures
3. Attendance Undertaking
4. Eligibility Undertaking
5. Gap Undertaking, if required as per format given by Faculty

1. Eligibility

Candidates applying for the degree of Master of Laws must have passed the LL.B. (General) or LL.B. (Special) or Five Years Integrated Law degree examination of this University or an examination recognized as equivalent thereto of any statutory University in India with at least 50% of marks or equivalent grade at the said examination shall be eligible for appearing in the written test for admission in LL.M. Part I. 5% relaxation shall be granted to candidates belonging to SC/ ST category.

CATEGORY	PERCENTAGE OF MARKS
General and EWS/ SEBC	At least 50%
SC and ST	At least 45%

Admissions shall be based on the score of **Entrance Test ONLY**. In case of more than one candidate having same score in Entrance test against number of available seats, then the marks at the qualifying examination of such candidates will be considered. For example, in case 2 seats are available and ten candidates of the same score in the Entrance Test list are there, then the marks obtained at qualifying examination will be considered.

Disclaimer: Admissions shall be based on the score of Entrance Test ONLY. Appearing in entrance test does not confirm the admission to the LL.M. Programme. Final confirmation of the admission in the programme will be based on the merit in entrance examination and fulfilment of eligibility criteria.

2. Reservation Policy

The SC, ST, SEBC candidates are required to submit relevant caste certificate from the Government of Gujarat. Only then, the said candidate shall be eligible to claim reservation in the relevant category. In case of SEBC candidates, the latest non creamy layer certificate will be required to be submitted.

The 10% reservation policy for EWS candidates introduced by Gujarat State shall be applicable for the admissions under Gujarat State and shall be available to the original inhabitant of Gujarat State i.e. those who have been permanently settled in Gujarat State on or prior to 01-04-1978. Such candidates shall have to produce EWS Certificate issued by the Government of Gujarat.

3. In case of Tie in the Entrance Test Score

In case of more than one candidate having same score in Entrance test against number of available seats, then the marks at the qualifying examination of such candidates will be considered.

For example, in case 2 seats are available and ten candidates of the same score in the Entrance Test list are there, then the marks obtained at qualifying examination will be considered.

4. Admission Procedure

4.1 Please visit www.msubaroda.ac.in for all instructions and declaration of Results and Merit Lists.

4.2 No applicant would be called personally, by post or by any other means for counseling and admission. The applicants are required to report on their own for counseling and for admission, as per the given schedule at their own cost.

4.3. Admission will be done entirely as per given schedule.

4.4 Non- submission of relevant original documents, non -remittance of payment of required admission fees or non-reporting of the candidate on scheduled dates will lead to automatic cancellation of admission.

4.5 Original testimonials will be retained by the Faculty till the completion of official procedure.


